### **Utah 3 Day Notice to Quit Form Non Payment eForms**

The Utah 3 Day Notice to Quit (Non-Payment) is required by Utah law that the landlord give at least a 3-day notice to pay or vacate, which must be in writing, when a tenant fails to pay rent on time. The notice must specify the exact amount of rent, late fees, and all other charges that must be paid before the three days (does not include the day of service) are up.

### **Utah Courts THREE DAY NOTICE TO PAY OR VACATE**

The landlord can use a Three-day pay or vacate notice if you owe rent and/or any other amount as a result of your oral or written agreement with the landlord. To calculate the three days, you don't count the day you receive the notice. You count the next three calendar days, including weekends and holidays. The day after you receive the notice is day one. If you pay the amount the landlord says you owe within the three days, you can stay.

Most rental agreements indicate a due date for the rent, usually the first of the month, and some indicate a grace period before the rent is to be considered late, usually three to five days later.

### **Good Questions How to Fight a 3 Day Eviction Notice**

A Three-Day Notice served on Wednesday will also expire at midnight on the following Monday, because the third day may not be a Saturday or Sunday. A Three-Day Notice to Pay Rent or Quit is not valid if served before the rent is delinquent. Therefore, it may not be served on the due date, only after the due date.

### **When To Deliver A 3 Day Eviction Notice to a Non Paying Tenant**

(3) When he or she continues in possession in person or by subtenant after a default in the payment of rent, and after notice in writing requiring in the alternative the payment of the rent or the surrender of the detained premises, served (in manner in RCW 59.12.040 provided) on behalf of the person entitled to the rent upon the person owing it, has remained uncomplied with for the period of
